We are committed to contributing to economic and social progress by adhering to tax laws and regulations and conducting our tax payments with integrity.

Our tax policy is formally reviewed and approved by the Board of Directors, and any substantial updates are subject to board-level sign-off. The Board, directly oversees the development and implementation of the tax policy, ensuring alignment with the company's values, responsible tax practices, and regulatory expectations. We conduct regular reviews and updates to maintain the policy's effectiveness and ensure compliance. These are our commitments to tax policy:

We recognize that aggressive tax avoidance undermines public trust, fiscal integrity, and the equitable functioning of tax systems. We therefore reject the use of artificial arrangements designed primarily to obtain tax benefits, even if technically legal, when such arrangements violate the spirit of tax law.

■ 遵守税收法律法规 Complying with Tax Laws and Regulations

我们严格遵守公司运营所在国家和地区的税收法律法规。我们致力于依法纳税,遵循各地税收政策,履行企业应尽的税收义务。

We strictly adhere to the spirit and the letter of the tax laws and regulations in all countries where we operate. Our commitment includes pay in taxes in accordance with local laws, respecting host country tax policies, and fulfilling our tax obligations responsibly.

■ 不转移价值至低税收管辖区 Avoiding Transferring Created Value to Low-Tax Jurisdictions 我们不会将公司创造的价值转移到低税收管辖区,以避免税负。东方日升的财务和税务政策均以公平合理的方式制定,确保税收在实际运营的国家和地区得到公正缴纳。

We are committed to not transferring value created to low-tax jurisdictions, regardless of legality, if such arrangements are primarily intended for reducing our tax liability and not supported by substantial business activities. Our financial and tax policies are designed to ensure fairness and compliance, with taxes paid lawfully in all countries and jurisdictions where we operate.

■ 不使用没有商业实质的税收结构 Avoidance of Tax Structures without Commercial Substance

我们不使用任何没有商业实质的税收结构。我们的所有财务和税务安排均基于实际的商业活动和经济实质,确保符合税收法规和商业道德。

We are committed to avoiding tax structures that lack genuine commercial substance. We only engage in transactions that are driven by authentic business purposes and not primarily motivated by tax minimization.

■ 遵守独立交易原则进行转让定价 Undertaking Transfer Pricing Using the Arm's Length Principle

我们按照独立交易原则进行转让定价,确保关联公司之间的交易价格与独立企业之间的交易价格相一 致。我们致力于通过公正透明的方式,确保转让定价符合国际标准和各国法规。

We are committed to implementing transfer pricing based on the arm's length principle, ensuring that transfer prices between related companies reflect what would be agreed upon between unrelated parties. Our commitment extends to ensuring that transfer pricing

practices adhere to international standards and national regulations in a fair and transparent manner.

■ 不利用保密管辖区或避税天堂 Avoidance of Secrecy Jurisdictions or "Tax Havens"

我们不会利用保密管辖区或所谓的"避税天堂"进行避税。我们坚持透明公开的财务和税务政策,确保所有税务行为均符合所在地的法律法规。

We are committed to refraining from using secrecy jurisdictions or so-called "tax havens" for tax avoidance. We do not channel profits through jurisdictions that lack transparency, exchange of tax information, or where we have no genuine operational presence. We adhere to transparent and open financial and tax policies, ensuring that our tax practices comply with local laws and regulations.
